## **Position Summary:**

The On-Call Substitute is responsible for supporting classroom and kitchen staff in the absence of staff. This includes bathroom and diapering, tooth brushing, and kitchen duties as necessary. This position assists in maintaining clean and safe indoor and outdoor environments.

## **Essential Functions:**

The duties identified below are the essential functions of the position. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

- Assist teachers in classroom routines, maintaining clean and safe indoor and outdoor learning environments
- Assist with implementation of lesson plans
- Assist with administering snacks and meals to children
- Prepare meals and serving carts in accordance with Family Style Dining principles
- Ensure cleaning of dishes, utensils, equipment, and kitchen
- Ensure compliance with Bauer Policies, State Licensing, and Head Start Program Performance Standards, and Child and Adult Care Food Program (CACFP) regulations
- Attend twice-monthly staff meetings, monthly Professional Development Days, quarterly All-Agency meetings, and annual Pre-Service

## **QUALIFICATIONS:**

To perform this position successfully, an individual must demonstrate regular, predictable attendance and be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge and skill required. The individual must be able to successfully pass background checks.
